#### **ENFORCEMENT NOTICE**

11 REGENT'S PARK TERRACE LONDON NW1 7EE

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

#### 2. THE LAND AFFECTED

Land at: 11 REGENT'S PARK TERRACE, LONDON, NW1 7EE

as shown, for the purposes of identification only, outlined in black on the attached plan.

#### 3. THE BREACH OF PLANNING CONTROL ALLEGED

**Without Planning Permission:** Unauthorised installation of roller shutter and shutter box to rear elevation at first floor level of dwelling house (Class C3).

#### 4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 *years*:
- b) The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.
- c) The solid roller shutter box, by reason of its design and location, is an unsightly form of development which has a detrimental impact on the special historic and architectural interest of the host building and the character and appearance of the adjoining properties and the surrounding Primrose Hill conservation area. The development is therefore contrary to policies CS14 (Promoting high quality places and conserving our heritage) and CS17 (Making Camden a safer place) of the London Borough of Camden Local Development Framework Core Strategy; and polices DP24 (Securing high quality design) and DP25 (Conserving Camden's heritage)

#### 5. WHAT YOU ARE REQUIRED TO DO

The notice shall require that within a period of 3 months of the notice taking effect the solid roller shutter, shutter box and associated fixtures and fittings shall be completely removed.

#### 6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 11 October 2013 unless an appeal is made against it beforehand.


