ENFORCEMENT NOTICE

OF 46 Camden High Street London NW1 0JH

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. THE LAND AFFECTED

Land at: 46 Camden High Street, London NW1 0JH

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without Planning Permission: The unauthorised use of the retail (Class A1) part of the ground floor level (63 sq m) as an estate agent (Class A2)

4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 10 years
- b) The use of the entire ground floor premises as an estate agent harms the function, vitality and viability of Camden High Street, by reason of the loss of retail floor space (Class A1) within a secondary retail frontage, contrary to policy CS7 (Promoting Camden's centres and shops) of the London Borough of Camden

Local Development Framework Core Strategy and policies DP10 (Helping and promoting small and independent shops), DP12 (Supporting strong centres and managing the impact of food, drink, entertainment and other town centre uses) of the London Borough of Camden Local Development Framework Development Policies.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of 18 months of the Notice taking effect:

Cease the use as an estate agency on the 63 sq m formerly used for retail purposes (As shown on the layout arrangement to the approved ground floor plan as part of planning permission ref: 2010/0605/P)

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **3 October 2013** unless an appeal is made against it beforehand.

Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications, Deemed Applications, Requests and Site Visits) (England) Regulations 2012/No.2920 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.
