1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. THE LAND AFFECTED

Land at: 71 Lincoln's Inn Fields, London WC2A 3JF

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without Planning Permission: Use of first and second floors as short term residential accommodation

4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last ten years
- b) The use of the studio flats at 1st and 2nd floor levels as short-stay accommodation, results in a loss of permanent housing in the borough, contrary to policy CS6 (Providing quality homes) of the London Borough of Camden Local Development Framework Core Strategy and policy DP2 (Making full use of Camden's capacity for housing) of the London Borough of Camden Local Development Framework Development Policies.

Council reference: EN13/0326

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of **two months** of the Notice taking effect, the use of the studio flats at 1st and 2nd floor level as short stay accommodation shall cease.

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 13 September 2013 unless an appeal is made against it beforehand.


You can appeal against this notice, but any appeal must be received or posted in time to be received by the Secretary of State before 13 September 2013.
