1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. THE LAND AFFECTED

Land at: 147 Highgate Road, London, NW5 1LJ

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without Planning Permission: The unauthorised installation of a roller shutter and shutter box.

4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.
- b) The roller shutter and associated shutter box, by reason of their appearance, form and impact on natural surveillance would be detrimental to community safety and to visual amenity failing to preserve or enhance the character and appearance of the host building and wider conservation area, contrary to policies CS13 (Promoting high quality places and conserving our heritage) and CS17 (Making Camden a safer place) of the London Borough of

Council reference: EN09/0269

Camden Core Strategy Development Plan Document or policies DP24 (Securing high quality design and DP30 (Shopfronts) of the London Borough of Camden Development Framework Development Policies.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of **3 months** of the Notice taking effect the following works are required to be undertaken to the front elevation of the building:

Remove the roller shutter and shutter box and fixtures and fittings and make good any resulting damage to the shop front

Compliance due date: 9 July 2013

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **9 April 2013** unless an appeal is made against it beforehand.
