#### **ENFORCEMENT NOTICE**

- OF Footpath opposite 26 Hampstead High Street London
  NW3 1QA
- 1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

#### 2. THE LAND AFFECTED

Land at: Footpath opposite 26 Hampstead High Street, London NW3 1QA as shown, for the purposes of identification only, outlined in black on the attached plan.

### 3. THE BREACH OF PLANNING CONTROL ALLEGED

**Without Planning Permission:** The unauthorised installation of 1 x BT equipment cabinet on the footway opposite No.26 Hampstead High Street.

#### 4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.
- b) The unauthorised equipment cabinet on the footway, by reason of its size, location and position, would be overly dominant and appear as an incongruous form of development that would harm the setting of the surrounding listed buildings and would fail to preserve and enhance the character and appearance of the streetscene and the Hampstead conservation area, contrary to policy CS14 (Promoting high quality places and conserving our heritage) of the London

Borough of Camden Local Development Framework Core Strategy and policies DP24 (Securing high quality design) and DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

### 5. WHAT YOU ARE REQUIRED TO DO

The Notice shall require within a period of **2 calendar months** of the Notice taking effect:

Remove the unauthorised equipment cabinet on the footway and make good any damage to the footway.

### 6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 25 June 2013 unless an appeal is made against it beforehand.

# Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

#### WHAT HAPPENS IF YOU DO NOT APPEAL


