**ENFORCEMENT NOTICE**

**OF 1f Parsifal Road**  
**London**  
**NW6 1UG**

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. **THE LAND AFFECTED**

**Land at: 1f Parsifal Road, London, NW6 1UG**

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

Non compliance with condition A.3 (b) of Class A, part 1 of the Town & Country Planning (General Permitted Development) Order 2008.  
(failure to obscure glaze and fix shut windows in a side elevation).

4. **REASONS FOR ISSUING THIS NOTICE:**

- a) It appears to the Council that the above breach of planning control has occurred within the last four years;
- b) The windows cause unacceptable overlooking and loss of privacy to neighbouring residential occupiers contrary to policies CS5-managing the impact of growth and development, CS14-promoting high quality places and conserving our heritage and DP-26 managing the impact of development on occupiers and neighbours of Camden Council's Local Development Framework 2010 and contrary to Camden Planning Guidance 6-Amenity.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

**5. WHAT YOU ARE REQUIRED TO DO**

The Notice shall require that within a period of **1 month** of the Notice taking effect,

- a) The windows in the south east elevation, first floor level, facing the rear of Lyncroft Gardens shall be obscured glazed and fixed shut.

**Compliance due date: 30 May 2013**

**6. WHEN THIS NOTICE TAKES EFFECT**

This notice takes effect on **30 April 2013** unless an appeal is made against it beforehand.

**Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002**

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications, Deemed Applications, Requests and Site Visits) (England) Regulations 2012/No.2920 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.

The fee is payable twice to the "London Borough of Camden", as the Local Planning Authority.
