ENFORCEMENT NOTICE

OF 37 - 39 Arkwright Road London NW3 6BJ

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. THE LAND AFFECTED

Land at: 37 - 39 Arkwright Road, London, NW3 6BJ

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without Planning Permission: The unauthorised installation of raised decking to the rear of the dwelling.

4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years:
- b) The raised decking area is detrimental to the character and appearance of the dwelling, and to the amenity of neighbouring properties due to overlooking and loss of privacy. This is contrary to Core Strategy policy CS5 and CS14, and Development Policy DP24, DP25, and DP26 of the Camden Local Development Framework.

Council reference: EN12/0182

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

The Notice shall require within a period of **4 calendar months** of the Notice taking effect:

- Remove the unauthorised raised decking to the rear of the dwelling.
- 2) Ground to be restored to the previous level prior to the works subject of this notice. The garden shall be finished with a general purpose grade topsoil (as defined in BS3882:2007) with a depth of 450mm (below the original level) and seed or turf the entire lawn.

Compliance due date: 10 August 2013

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 10 April 2013 unless an appeal is made against it beforehand.

YOUR RIGHT OF APPEAL


You can appeal against this notice, but any appeal must be received or posted in time to be received by the Secretary of State before 10 April 2013

WHAT HAPPENS IF YOU DO NOT APPEAL

Failure to comply with an enforcement notice, which has taken effect, can result in prosecution and/or remedial action by the Council.
