ENFORCEMENT NOTICE

OF 18 North Villas
NW1 9BJ

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. **THE LAND AFFECTED**

Land at: 18 North Villas, NW1 9BJ

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

Without Planning Permission: Installation of 1x satellite dish to the front elevation of the building above front door

4. **REASONS FOR ISSUING THIS NOTICE:**

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years
- b) The satellite dish by reason of its size, location and visual prominence, results in demonstrable harm to the character and appearance of the host building, the North Villas streetscene and the Camden Square Conservation Area contrary to policies CS14 (Promoting high quality places and conserving our heritage) and the London Borough of Camden Local Development Framework Development Policies DP24 (Securing high quality design) and

Council reference: EN12/1035

DP25 (Conserving Camden's Heritage) of the London Borough of
Camden Development Policies.

**The Council do not consider that planning permission should be
given because planning conditions could not overcome these
problems.**

5. WHAT YOU ARE REQUIRED TO DO

Within a period of 1 month of the Notice taking effect:

Remove the satellite dish and all associated fixtures and fittings and
make good any damage to the building.

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **27 March 2013** unless an appeal is made
against it beforehand.

Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications, Deemed Applications, Requests and Site Visits) (England) Regulations 2012/No.2920 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.
