1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. 3. THE BREACH OF PLANNING CONTROL ALLEGED

Without Planning Permission: Erection of non - retractable metal canopy to shop front.

4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.
- b) The canopy is considered to represent a visually incongruous feature on the front elevation of the property and detracts from the character of host building and street scene contrary to the London Borough of Camden Local Development Framework Core Strategy 2010 policies CS5 (Managing the impact of growth and development), CS14 (Promoting high quality places and conserving our heritage) and the London Borough of Camden Local Development Framework Development Policy DP24 (Securing high quality design) and DP30 (Shopfronts) of the London Borough of Camden Development Policies.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

WHAT YOU ARE REQUIRED TO DO 5.

Completely remove the unauthorised canopy and all associated fitments; and make 1) good any damage to the shop front resulting from the removal of the canopy.
