They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without Planning Permission:

The unauthorised change of use from a nurse's hostel into a substandard House in Multiple Occupation

4. REASONS FOR ISSUING THIS NOTICE:
 - a) It appears to the Council that the above breach of planning control has occurred within the last ten years.

- b) The HMO accommodation is considered to provide an unacceptable standard of accommodation in terms of size and layout to the detriment of the amenity of the occupiers. The development is contrary to policy DP9 (Student housing, bedsits and other housing with shared facilities) and DP26 (Managing the impact of development on occupiers and neighbours) of the Council's Local Development Framework 2010 and residential development standards contained in Camden Planning Guidance 2011.
- c) The development fails to make full use of Camden's capacity for housing, the over concentration of HMO accommodation and the lack of a variety of types of accommodation is contrary to policies DP5 (Homes of different sizes), DP9 (Student housing, bedsits and other housing with shared facilities) and CS6 (Providing quality homes) of the Council's Local Development Framework 2010.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Cease the use of the property as a House in Multiple Occupation.

Compliance due date: Within a period of 6 months from the date of the Notice taking effect

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 21 February 2012 unless an appeal is made against it beforehand.

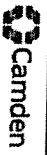

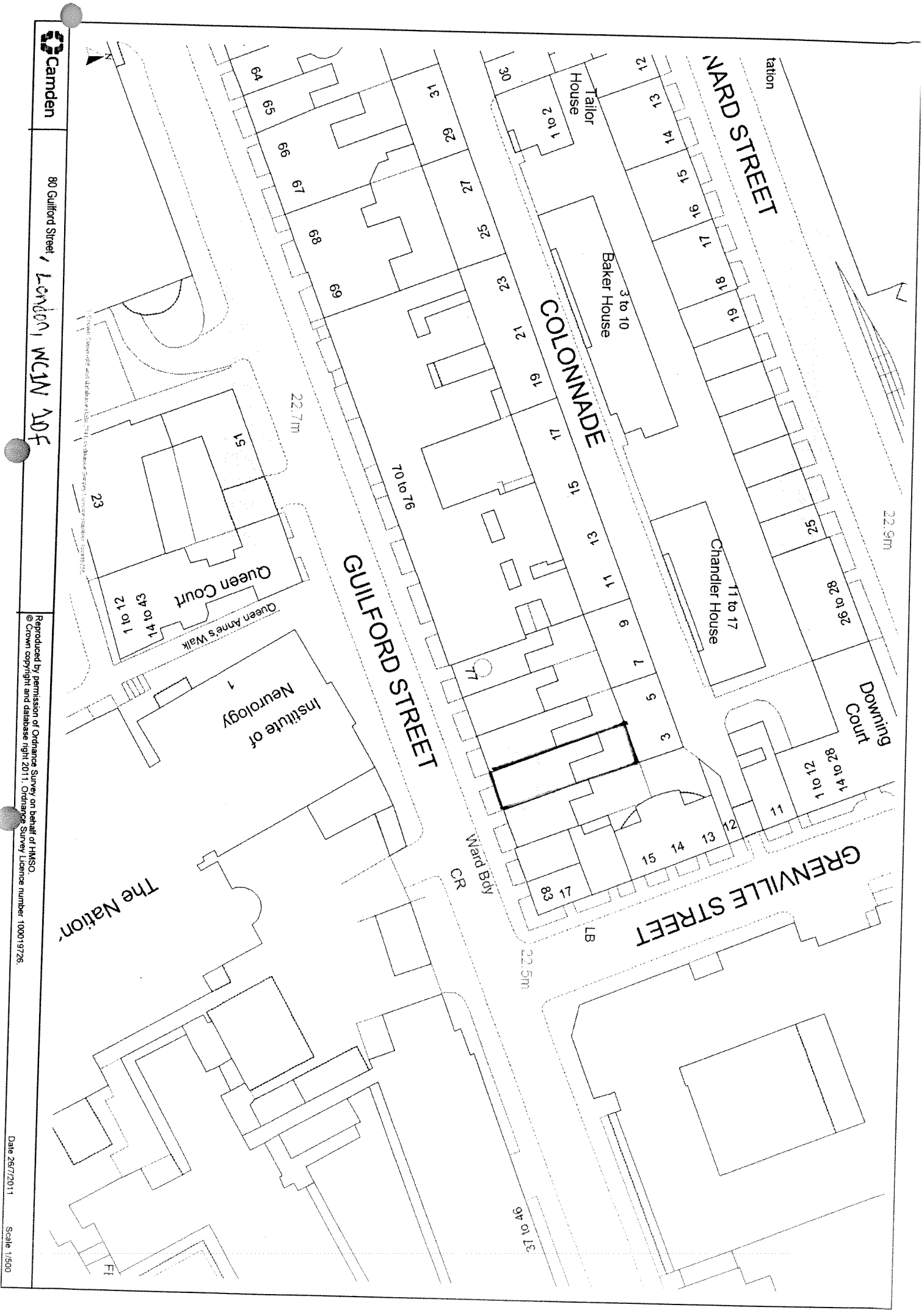
