ENFORCEMENT NOTICE

1. **THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.**

2. **THE LAND AFFECTED**

Land at: **35 Heath Drive, London, NW3 7SD**

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

Without Planning Permission:

The unauthorised erection of timber entrance gates and timber fencing alongside the boundary with Bracknell Way

4. **REASONS FOR ISSUING THIS NOTICE:**

It appears to the Council that the above breach of planning control has occurred within the last 4 years

- b) The timber entrance gates and timber fencing which borders Bracknell Way by reason of their height, materials and appearance would be detrimental to the character and appearance of the building, streetscene and the Redington / Frognal Conservation Area contrary to Policies CS14 (Promoting high quality places and conserving our heritage), DP24 (Securing high quality design), DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Core Strategy and Development Policies 2010.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO


Remove the timber vehicle and timber pedestrian entrance gates and the timber fencing along the boundary with Bracknell Way

Compliance due date: within three months from the date of the notice taking effect

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 18 October 2011 unless an appeal is made against it beforehand.

Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

If you appeal against the notice on Ground (a) “That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged” there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications and Deemed Applications) Regulations 1989 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.

The fee is payable both to the “Department for Communities and Local Government” for the Planning Inspectorate appeal, and also to the “London Borough of Camden”, as the Local Planning Authority.

WHAT HAPPENS IF YOU DO NOT APPEAL

If you do not appeal against this enforcement notice, it will take effect on 18 day of October 2010, and you must then ensure that the required steps for complying with it, for which you may held responsible, are taken within the period specified in the notice. Failure to comply with an enforcement notice, which has taken effect, can result in prosecution and/or remedial action by the Council.
