

**THE LONDON BOROUGH OF CAMDEN****TOWN AND COUNTRY PLANNING ACT 1990 (AS AMENDED)****ENFORCEMENT NOTICE**

81c Endell Street

1. **THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.**

2. **THE LAND AFFECTED**

Land at: **81c Endell Street, London, WC2H 9AJ**

**as shown, for the purposes of identification only, outlined in black on the attached plan and for clarification on the attached sketched marked A and B.**

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

**Without Planning Permission: Unauthorised change of use from B1 office space to C3 residential house.**

4. **REASONS FOR ISSUING THIS NOTICE:**

- a) **It appears to the Council that the above breach of planning control has occurred within the last 4 years.**
- b) **The unauthorised change of use to a C3 house is considered to result in the loss of existing small business space within the Borough contrary to Policies CS8 (Promoting a successful and inclusive Camden) and Policy DP13 (Employment premises and sites) of the London Borough of Camden Local Development Framework 2010.**

- c) The unauthorised change of use of the premises from B1 office to C3 residential house is likely to contribute unacceptably to parking congestion in the Borough, contrary to Policies CS11( Promoting sustainable and efficient travel) and DP18 (Parking standards and limiting the availability of car parking) of the London Borough of Camden Local Development Framework 2011.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

**Use of the premises as a house shall cease and all associated fixtures and fittings shall be removed.**

**Compliance due date:** 3 months from the date this notice takes effect.

6. WHEN THIS NOTICE TAKES EFFECT

**This notice takes effect on 2 September 2011 unless an appeal is made against it beforehand.**

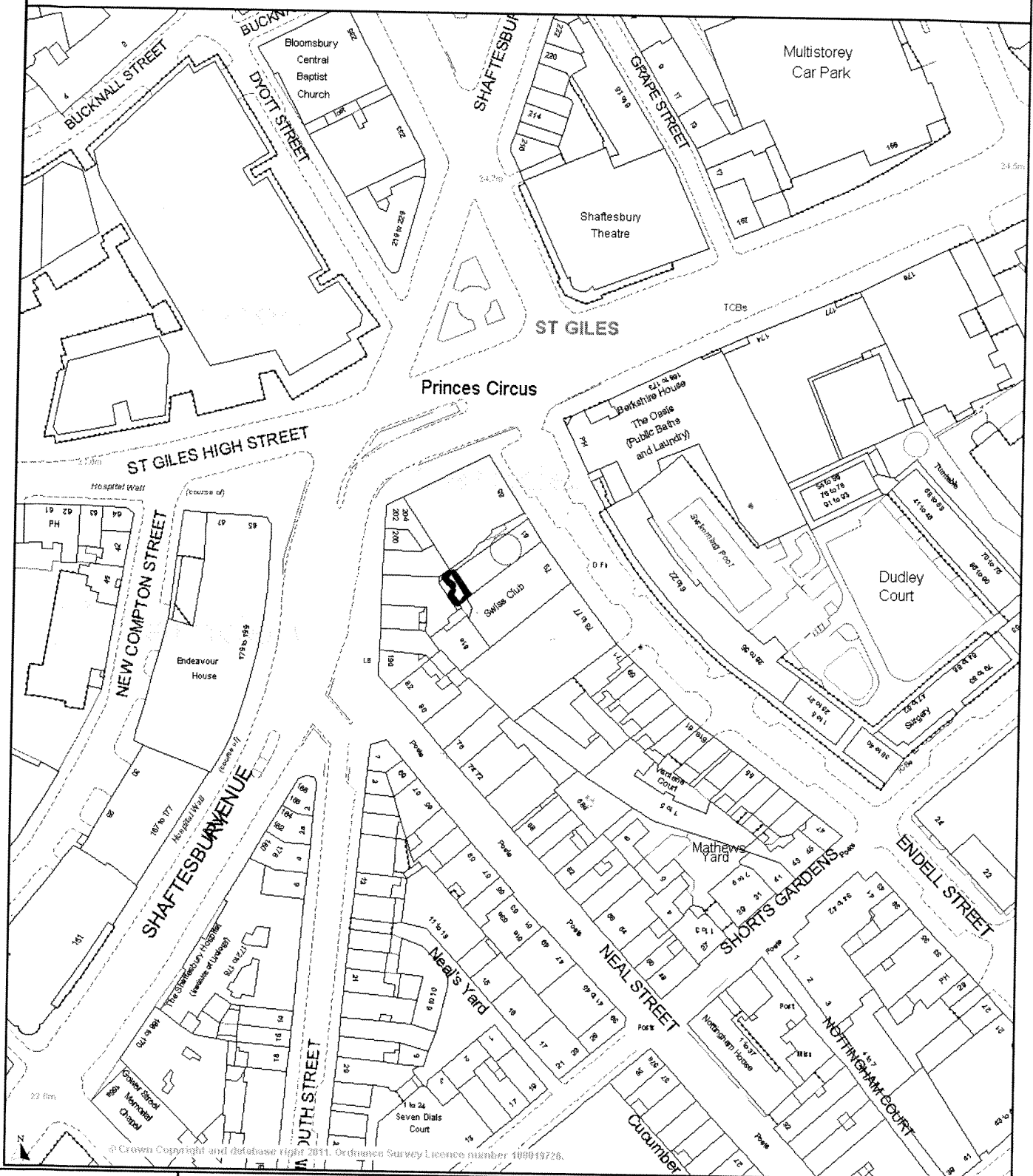

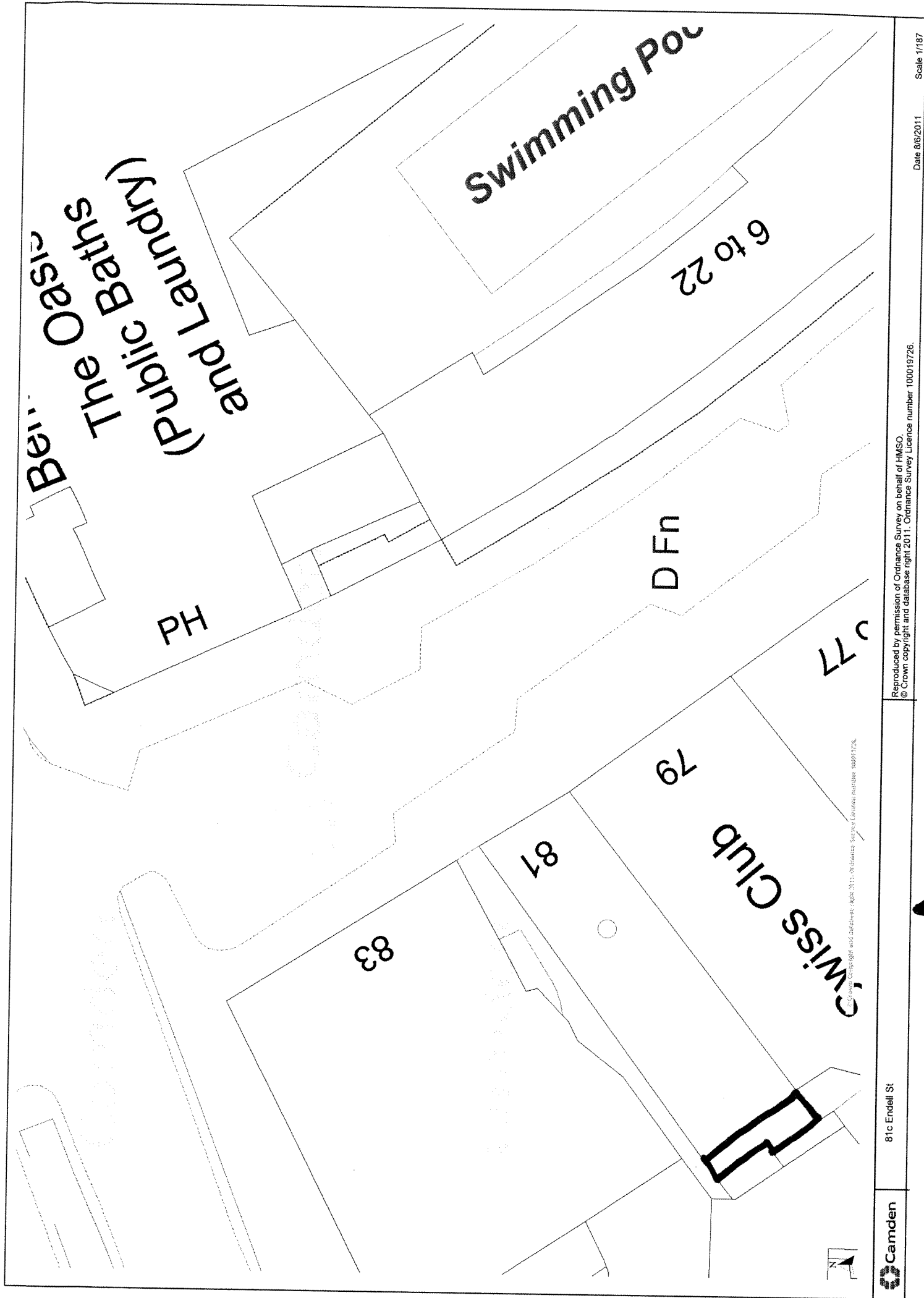

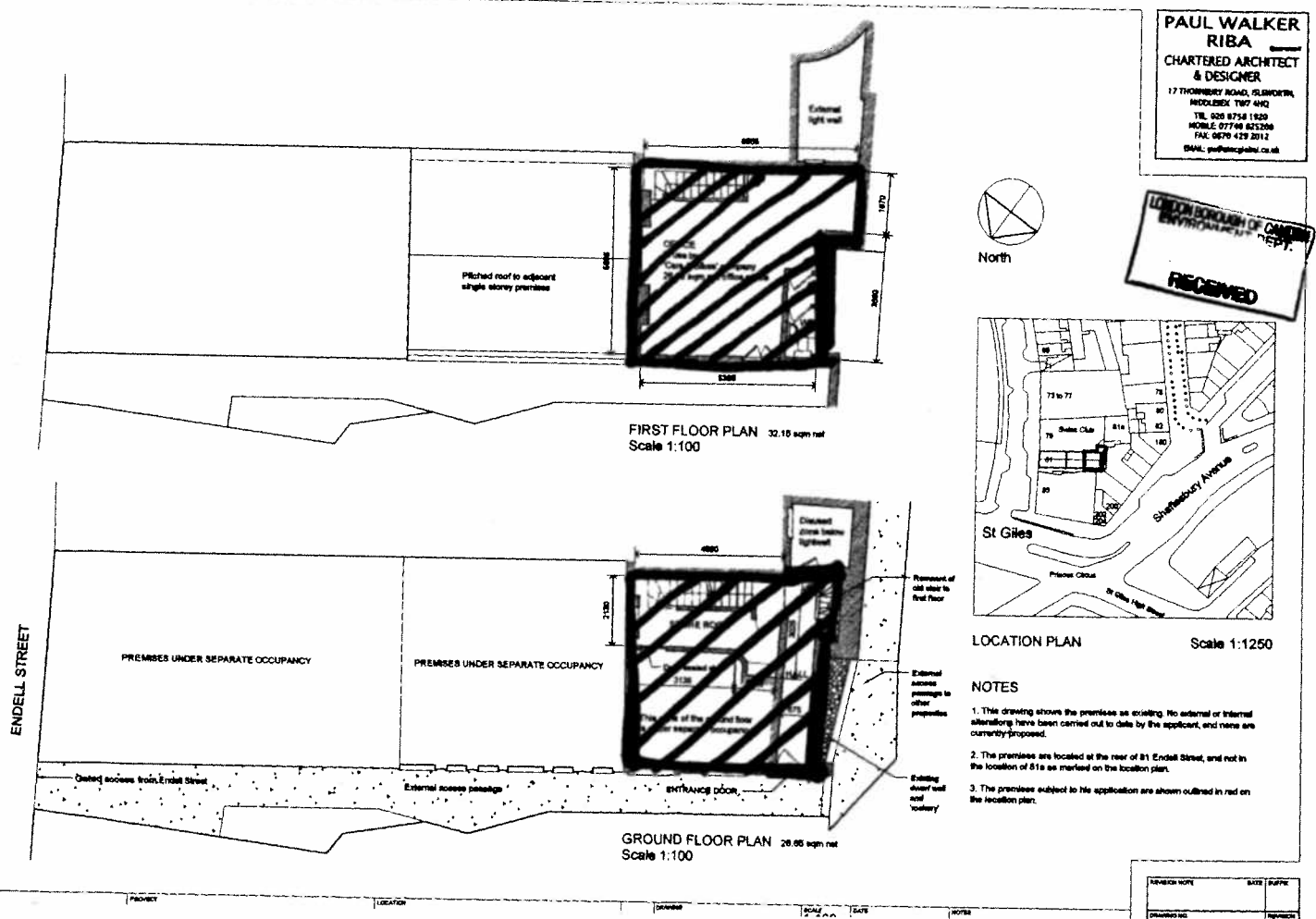
