**ENFORCEMENT NOTICE**

St Giles Hotel  
Bedford Avenue

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.
  
2. THE LAND AFFECTED  
  
Land at: **St Giles Hotel, Bedford Avenue, London, WC1B 3AS**  
  
as shown, for the purposes of identification only, outlined in black on the attached plan.
  
3. THE BREACH OF PLANNING CONTROL ALLEGED  
  
Without Planning Permission:  
Unauthorised retention of roller shutter to shopfront on Bedford Avenue elevation in connection with hotel use (Class C1)
  
4. REASONS FOR ISSUING THIS NOTICE:  
  
It appears to the Council that the above breach of planning control has occurred within the last 4 years



- b) *The retention of the roller shutters, by reason of their design and appearance, would prevent natural surveillance and would be detrimental to the character and appearance of the host property and the area generally, contrary the London Borough of Camden Local Development Framework Core Strategy 2010 policies CS14 (Promoting high quality places and conserving our heritage) and CS17 (Making Camden a safer place); and the London Borough of Camden Local Development Framework Development Policies DP24 (Securing high quality design) and DP30 (Shopfronts) of the London Borough of Camden Development Policies.*

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

- 1) Remove the unauthorised roller shutter, shutter box and associated fixtures and fittings
- 2) Make good any damage from removing the roller shutter and associated fittings

**Compliance due date:** Within three months from the date of the notice taking effect

6. WHEN THIS NOTICE TAKES EFFECT

**This notice takes effect on 15 November 2011 unless an appeal is made against it beforehand.**

Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications and Deemed Applications) Regulations 1989 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.
