#### LISTED BUILDING ENFORCEMENT NOTICE

OF 16 Church Row London NW3 6UP

1. **THIS IS A FORMAL NOTICE**, which is issued by the Council being the Local Planning Authority for the purposes of Section 38 of the above Act because it appears to them that there has been a contravention of Section 8 of the Act, in respect of the building within a conservation area described below. The Council considers it necessary to issue this notice for the reasons set out in paragraph 4 below.

### 2. THE LISTED BUILDING.

Land at: 16 Church Row, London NW3 6UP as shown, for the purposes of identification only, outlined in black on the attached plan.

#### THE CONTRAVENTION ALLEGED.

**Without listed building consent**: Installation of retractable awnings to rear elevation windows at ground, first, second and third floor levels of Grade II Listed Building.

### 4. REASONS FOR ISSUING THIS NOTICE

- a) The work outlined above has been carried out to this Grade (II) listed building without the benefit of Listed Building Consent
- b) The installation of retractable blinds has resulted in harm to the architectural integrity and special character of the Grade II listed building, as well as harming the setting of neighbouring listed buildings, contrary to policies CS14 (Promoting high quality places and conserving our heritage), DP24 (Securing high quality design) and DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework 2011.
- c) The retractable blinds, by reason of their inappropriate appearance, represent an incongruous feature within the terrace and do not preserve

and enhance the character or appearance of the Hampstead Conservation Area, contrary to the London Borough of Camden Local Development Framework Core Strategy, with particular regard to policies CS5 (Managing the impact of growth and development) and CS14 (Promoting high quality places and conserving our heritage), and the London Borough of Camden Local Development Framework Development Policies, with particular regard to policies DP24 (Securing high quality design) and DP25 (Conserving Camden's heritage).

#### 5. WHAT YOU ARE REQUIRED TO DO

Within 3 months from the date of this Notice taking effect:

Remove the awnings and make good any damage to the elevation.

#### 6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **2 December 2013**, unless an appeal is made against it beforehand.
