ENFORCEMENT NOTICE

OF 4 Goodge Place London W1T 4SB

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information

2. THE LAND AFFECTED

Land at: 4 Goodge Place, London W1T 4SB

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without Planning Permission: The installation of roller shutter at ground floor Office (Class B1)

4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.
- b) The retention of the solid roller shutter, by reason of its design and appearance, would prevent natural surveillance and would be detrimental to the character and appearance of the building and the Bloomsbury conservation area, contrary to the London Borough of Camden Local Development Framework Core Strategy 2010 policies CS14 (Promoting high quality places and conserving our heritage) and CS17 (Making Camden a safer place); and the

London Borough of Camden Local Development Framework Development Policies DP24 (Securing high quality design) DP25 (Conserving Camden's heritage) and DP30 (Shopfronts) of the London Borough of Camden Development Policies.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of three months of the Notice taking effect:

Completely remove the shutters and make good any damage to the frontage.

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **24 April 2014** unless an appeal is made against it beforehand.
