The Council has been notified of an appeal which has been made to the Planning Inspectorate which is part of the Department for Communities and Local Government. The appeal concerns an application for;

Change of use from residential floorspace on upper floors, ancillary to public house below, to create 3×1 bed, 1×2 bed and 1×3 bed flats, plus the erection of a 3rd floor mansard roof extension with 7 dormer windows, following demolition of existing 2nd floor mansard, and alterations to rear elevation.

The appeal will be decided by means of an <u>informal hearing</u> held by a Planning Inspector. The hearing date is currently being arranged. I will write to you again to confirm the date, time and venue of the hearing.
