- a) The work outlined above has been carried out to this Grade II listed building without the benefit of Listed Building Consent.
- b) The fixing of a satellite dish on the railings at ground floor level of this Grade II Listed Building detracts from the special historic and architectural interest of the building by virtue of its visual impact contrary to policy CS14 – Promoting high quality places of the Camden Core Strategy and policy DP25 - Conserving our heritage of the Camden Local Development Framework.

Permanently remove from the railings the satellite dish and all associated wiring, fixtures and fittings and any damage caused shall be made good.
