ENFORCEMENT NOTICE

OF Flat 6, 133 West End Lane London NW6 2PE

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. THE LAND AFFECTED

Land at: Flat 6, 133 West End Lane, London, NW6 2PE

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without Planning Permission: Satellite dish erected on the side of the property fronting onto Dynham Road.

4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.
- b) The satellite dish by reason of its size, appearance and location is an unsympathetic and obtrusive addition to the building. It has a detrimental impact on the appearance of the building and neighbouring properties and the character and appearance of the South Hampstead Conservation Area. The works are not in accordance with the London Borough of Camden Local Development Framework, in particular policies CS14 (Promoting

high quality places and conserving our heritage), DP24 (Securing High Quality Design) or DP25 (Conserving Camden's heritage).

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

Within a period of one month of the Notice taking effect:

- Remove the satellite dish and its associate fixtures and fittings from the side elevation of the property.
- 2) Remove all debris from the premises as a result of the above requirement.

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 11 April 2013 unless an appeal is made against it beforehand.
