1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. THE LAND AFFECTED

Land at: 106-108 Cromer Street, London WC1H 8BZ

as shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED

Without Planning Permission: Unauthorised installation of 1x satellite dish on the elevation fronting Cromer Street and Tonbridge Street at third floor level.

4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years
- b) The satellite dish by reason of its location and visual prominence creates an incongruous feature that detracts from the visual amenity of the host building and the Bloomsbury Conservation Area contrary to Core Strategy policy CS14 (Promoting high quality places and conserving our heritage) and development policies DP24 (Securing High Quality Design) and DP25 (Conserving Camden's heritage) of the Local Development Framework Core Strategy 2010.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO

The Notice shall require that, within a period of **one month** of the Notice taking effect:

- 1) The removal of 1 x satellite dish on the elevation fronting Cromer Street and Tonbridge Street at third floor level
- 2) Make good any damage to the building

6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 19 August 2013 unless an appeal is made against it beforehand.


