ENFORCEMENT NOTICE

RE: 100 CLEVELAND STREET, LONDON W1T 6NS

OPERATIONAL DEVELOPMENT

ISSUED BY: THE LONDON BOROUGH OF CAMDEN

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations.

2. THE LAND AFFECTED. Land and premises at

100 CLEVELAND STREET, LONDON W1T 6NS

("the Premises").

The Premises are shown, for the purposes of identification only, outlined in black on the attached plan.

3. THE BREACH OF PLANNING CONTROL ALLEGED.

Without Planning Permission:

The installation of two satellite dishes, one located at roof level on the front elevation, and the other located at first floor level on the front elevation of the Premises.

4. REASONS FOR ISSUING THIS NOTICE

()

- a) It appears to the Council that the above breach of planning control has occurred within the last **4 years**.
- b) The unauthorised satellite dishes are considered harmful, by virtue of their incongruous nature and their prominence within the street scene. They are therefore considered to have a detrimental impact on the character and appearance of the building and the Bloomsbury Conservation Area. The unauthorised satellite dishes are also considered to be contrary to policies EN31 [Character and appearance of Conservation Areas] PU8 [Telecommunications] of the London Borough of Camden Unitary Development Plan, and advice contained within the Supplementary Planning Guidance.

The Council do not consider that planning permission should be given, because planning conditions could not overcome these problems.

5. WHAT YOU ARE REQUIRED TO DO.

- 1. The satellite dishes, together will all associated fixtures and fittings, shall be completely and permanently removed from the first floor front elevation and the roof level front elevation of the property.
- 2. Any resultant damage be made good to an appropriate and proper standard, and the chimneystack restored to its former condition.

You are to comply with the above requirements within 1 month of this notice taking effect.

6. WHEN THIS NOTICE TAKES EFFECT.

This notice takes effect on 23 day of **December** 2005 unless an appeal is made against it beforehand.

ANNEX YOUR RIGHT OF APPEAL

You can appeal against this notice, but any appeal must be received, or posted in time to be received, by the Secretary of State before 23 day of **December 2005**. The enclosed booklet "Enforcement Appeals - A Guide to Procedure, sets out your rights. Read it carefully. You may use the enclosed appeal forms.

(a) One is for you to send to the Secretary of State if you decide to appeal, together with a copy of this enforcement notice.

WHAT HAPPENS IF YOU DO NOT APPEAL

If you do not appeal against this enforcement notice, it will take effect on **23** day of **December 2005**, and you must then ensure that the required steps for complying with it, for which you may be held responsible, are taken within the period specified in the notice. Failure to comply with an enforcement notice, which has taken effect, can result in prosecution and/or remedial action by the Council.


Your attention is drawn to the information contained in the enclosed Planning Inspectorate booklet "Making Your Enforcement Appeal".

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged", there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications and Deemed Applications) Regulations 1989 for the deemed application for planning permission for the development alleged to be in breach of planning control in the enforcement notice.

The fee is payable both to the "Office of the Deputy Prime Minister" [ODPM] for the Planning Inspectorate appeal, and also to the "London Borough of Camden", as the Local Planning Authority.

If you wish to appeal under Ground (a), the fee payable to the "Office of the Deputy Prime Minister" should accompany the copy of the appeal form sent to the **Planning Inspectorate, P O Box 326, Bristol, BS99 7XF**. The fee is **£135.**

The fee payable to the "London Borough of Camden" should accompany the copy of the appeal form sent to the Council, at the following address: Environment Department (Planning Division), London Borough of Camden, Fifth Floor Town Hall, Argyle Street, London WC1H 8EQ. The fee is also £135.
