## LISTED BUILDING ENFORCEMENT NOTICE

OF **42 Tavistock Place** London WC1H 9RE

1. THIS IS A FORMAL NOTICE, which is issued by the Council being the Local Planning Authority for the purposes of Section 38 of the above Act because it appears to them that there has been a contravention of Section 8 of the Act, in respect of the building within a conservation area described below. The Council considers it necessary to issue this notice for the reasons set out in paragraph 4 below.

#### 2. THE LISTED BUILDING.

Land at: 42 Tavistock Place, London WC1H 9RE as shown, for the purposes of identification only, outlined in black on the

attached plan.

#### 3. THE CONTRAVENTION ALLEGED

Without listed building consent: Unauthorised works to a listed building consisting of replacement of timber sliding sash window in front basement with uPVC casement window and replacement of black painted timber six panel front doors with modern brown timber door.

#### 4. **REASONS FOR ISSUING THIS NOTICE**

- The work outlined above has been carried out to this Grade II listed building without the benefit of Listed Building Consent.
- b) The door and window by reason of their design, materials and colour are harmful to the special architectural and historic interest of the listed building contrary to policies CS14 (promoting high quality places and conserving our heritage) and DP25 (conserving our heritage) of the Local Development Framework Development Policies.

## 5. WHAT YOU ARE REQUIRED TO DO

Within a period of three months of the Notice taking effect:

the modern casement window in the front elevation at basement level shall be replaced with a three over three, sliding, timber sash window to match that which was removed and the brown timber front door shall be replaced with a black timber six panel door, raised and fielded, to match that which was removed or that is existing at no. 38 Tavistock Place.

## 6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on **28 August 2014**, unless an appeal is made against it beforehand.
