## 7. Identification Of Tree(s) And Description Of Works continued ...

The ash is dominate, and has forced the 'softer' maple to grow out and away from it. The maple has become very lopsided and quite 'leaned': sort of 'one sided'. Ultimately, if not now, it is a candidate for falling.

The maple has also reached a size, where it is lifting the paved walkway which runs adjacent. Shading is an issue, but not the dominate one.

The ash is a very large tree in its own respect and will maintain the visuals of the street adjacent. Further, a young maple has been planted directly across the street which will grow to give a nice canopy effect for travelers using the street.

Note: this maple was trimmed (via an application) about 5 years ago.

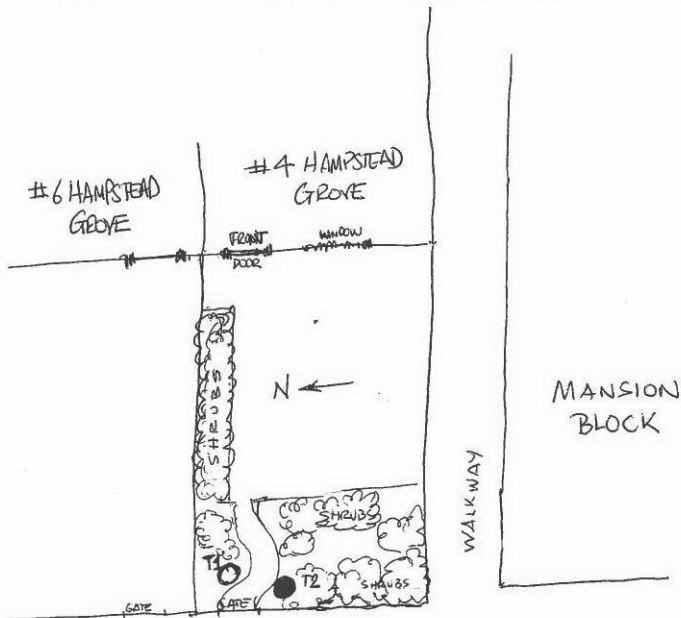
