Dear Ms Peck.

I understand you are the planning officer in charge of making a decision about the proposed development on Swains Lane and I am contacting you to voice my opinion on the scheme and the latest set of visuals the developers have produced.

I honestly cannot see how the proposed development could be more out of kilter with the area if they tried. At present I am a regular visitor to shop and dine on Swains Lane but this would stop were the development to go ahead. The road and its surrounding area are unique and provide a vital respite from the sort of ubiquitous architecture the developers are proposing on the site.

Furthermore I feel this development would cause considerable traffic congestion in the area. A quick visit to any Tesco Express or Sainsbury's Local in the area would explain why - these shops are supplied by heavy goods vehicles so that the supermarket chains can cut down on delivery costs and deliver to multiple London stores in one go (as opposed to independent shops which generally have deliveries made by vans). These large lorries cause enormous traffic problems when they park in small London streets to carry out their deliveries. They block the road and cause local traffic to queue as they attempt to go round the stationary lorry.

Finally, you might be aware that Swains Lane is one of the most famous spots in London for cyclists - if not the most famous hill climb in London. It has been included in many lists of top 100 hill climbing destinations for cyclists in the country. Cyclists from all over London travel to the area to ride up the hill in a relatively (by London standards) traffic free environment. Many of these cyclists then spend money in the cafes on Swains Lane. Should this development go ahead I know many of these cyclists will simply avoid the area as they will not want to deal with the dangerous meeting situations caused by traffic building up as deliveries are made.

Your comments on the planning application: I am concerned that the planting as set out in the landscape statement will be entirely reliant on the residents maintenance, as access to all landscape will be through private apartments. The choice of trees for the roof gardens is very strange particularly, Prunus avium, this naturally grows over 12m high with a spread of over 8m so cannot see how these large trees can thrive long term in planters. It should be a conditioned that ALL planters are supplied with an automatic irrigation system that works centrally and is managed the building maintenance company to ensure long term sustainability of the planting.
