I see the comments made by the applicant's representative to my latest email and cannot avoid sending a further communication:-

1. the second paragraph "I understand [...] that they have spoken with Mr De Fanis when the works commenced [...] and gave him contact details should he have any complaints è..+" is simply not true. This has never happened

2. re opening times the phrase "the application is being submitted for the proposed hours etc." suggests that the Council should "judge what the applicant say they will do, not what they are doing already", which is frankly ludicrous. If the limits to opening hours and noise levels are not respected now while the application is still under evaluation, how will they be respected once the application is granted.

This is really my main concern, how can we be sure that any contraints will be respected. The Council cannot wash its hands hiding behind constrains that make an approval of the application look reasonable but that then in practice will not monitored or enforced, leaving the residents at the mercy of the shisha shop and its customers.
