The " tree plans" contractors document also lists them as 1 tree and has a simple drawing somewhat ambiguously showing two. I believe this is deliberately ambiguous. The intention behind the application is clearly to cut down both trees. This is disingenuous at best and at worst fraudulent. These trees are NOT owned by Elmwood ; they are on the land of and the property of Wildwood Grove Freehold Limited. The council"s own map showing borders of Elmwood also clearly bear this out. The applicants are perfectly aware of this and they are perfectly aware that the company does not wish and would not wish these to be cut down; there have been disputes in the past. The comment on the "tree plans" form that "ownership [is] uncertain" is plain wrong , once again disingenuous at best , and itself inconsistent with the application order - Reference C574 2006, (which also clearly states : "2 x Sycamore on land at or adjacent") Surely this is specifically in place to stop this kind of unilateral vandalism ? Damage to property is also claimed but no evidence of damage has been submitted. Further, the comments on the contractors form "too close "honeydew" " do not make particular sense or sufficiently constitute grounds for felling.
