The gardens were deliberately preserved as community space in the original designs of Barrington Court, by Powell and Moya, highly respected and influential post war architects. However it seems that in a short sighted and desperate bid to balance its books, the council is trying to sell off this and other public land to reduce its deficit. One of the gardens has a massive copper beach tree that will be felled by the new houses. We need more trees, especially mature trees - not less! They are the vital lungs of the city!</p> <p>To add insult to injury, as a council you have tried to deceive residents by claiming in the plans that the land is "derelict" offering "no community value", where in fact they are thriving allotments in constant use. That is truly underhand and deeply shocking behaviour.</p> <p>For all our sakes, we need to protect, enhance and promote more green space, not less. There is precious little green space in the Gospel Oak estates as it. Therefore I ask that you please very carefully consider the devastating impact this will have on hundreds of people in the local community if you bulldoze ahead with this short sighted plan.</p>
