


Dear Mr Thuarire

I wish to object in the strongest possible terms to these applications which would be extremely damaging to the setting of the Heath and to long-established views.

More specifically:

- The planning permission for building the flats as part of the redevelopment of the Athlone House site required, by virtue of a Section 106 Agreement, the house to be retained and restored. The flats have been constructed so the conditions have been accepted and need to be enforced.
- 2. Should, and I have yet to be satisfied that this is the case, the house be in too bad a state to be restored, any variation to the conditions should reflect that that the site is in Metropolitan Open Land so that any rebuilding must not be materially larger than the current house. The proposed new house, although much smaller than the earlier proposal, is still well over 10% larger than the area of the existing house an so well over an acceptable replacement on Metropolitan Open Land.
- The current house is barely visible from the Heath whereas the size, scale, style, colours and detail of the proposed new house is still too intrusive and would damage the character of this popular area of the Heath immediately adjacent to Kenwood.

I urge Camden to reject these proposals and to take all necessary steps to ensure full compliance with the terms of the Section 106 Agreement.

Athlone House is one of London's finest remaining Victorian buildings and affords a fantastic view to the millions of Londoners who use Hampstead Heath every year. 



I have, in fact, a very personal reason for wanting Athlone House to be preserved.

As a school girl in the 1930s, my best friend was the niece of the owners of Athlone House at that time. As very earnest and committed tennis players (and members of our School Tennis Team) Anne and I were allowed to practice tennis playing on the tennis court down on the court below the house - regularly at weekends and sometimes also on Wednesdays. I write as the current chairman of the Camden Civic Society, the Borough's only fully local pan-Camden environmental protection organisation, to comment in forthright terms on the current application to demolish the existing Athlone House and replaced it by a new modern building.

The application is in full denial of local opinion and of the original planning permission. If planning and planners exist to protect local heritage, integrity and honesty, then Camden must fight this application to the last hurdle. The original application exchanged the right to build a series of remarkably unattractive but presumably profitable flats for the retention and rehabilitation of Athlone House. The fact that the House has been (deliberately?) neglected and is now more expensive to rehabilitate is not the Council's fault. An accusation of deliberate neglect leading to its state as "a damaged unlisted building" can surely an only be laid against the owners of the House for which they cannot now be allowed to profit.
