I am writing to object strongly to the above planning application's renewed attempt to demolish Athlone House and to build a new house in its place, for the following reasons:

Athlone House is one of Hampstead's and Highgate's most distinctive Victorian houses with many interesting exterior and interior features. It is an historic landmark visible from Hampstead Heath and is architecturally sympathetic to St Michael's Church and Witanhurst which are also visible from the Heath. It should not be demolished but should be sympathetically restored.

Planning permission was originally given to build flats in the grounds of Athlone House on the condition that the house itself was restored. It is very surprising that this application is being submitted and an another attempt made to demolish rather than restore the house contrary to the this original planning permission. That Athlone House is now owned by new developers should make no difference to this.

The much greater size of the replacement building would contravene the rules on rebuilding houses in Metropolitan Open Land and would be out of scale with and dominate the neighbouring area of Hampstead Heath.

This application goes against the Section 106 Agreement for this site requiring the house to be kept and restored. It is infamous that they have gone against this agreement not to demolish it.

I am writing to register my strong objections to the planning application to demolish Athlone House and construct a new building on the site.

I am astonished that such an application is even possible, given the conditions upon which planning permission was granted in 2005 for the construction of new flats in Athlone's grounds: namely the restoration and maintenance of Athlone House.

My grounds for objecting are as follows.

- The requirement to restore and maintain Athlone House clearly precludes its demolition. The fact that the site has been sold must merely transfer the obligation to the new owner.
- 2) Athlone House is a landmark building: its destruction would diminish the architectural fabric of Highgate. It is handsome, distinctive and historic. The view of Athlone House from Hampstead Heath is extremely pleasing (one that I regularly enjoy - along with thousands of others). Having also visited the building in its time as a care home, I have also seen for myself its delightful architectural detailing, which deserves to be preserved.
- 3) The footprint of the proposed replacement would be more than sixty percent bigger than Athlone House. It would therefore contravene the rules on rebuilding houses in Metropolitan Open Land.
- 4) Viewed from the Heath, the weathered bricks of Athlone House blend attractively with Witanhurst. The stone fabric of the proposed replacement would break this sense of architectural unity, while its bulk would give it an overbearing aspect, ensuring it dominated and spoilt the view from the Heath.

I believe that we all have a duty to look after the architectural environment for present and future generations. Athlone House is an important building: we should be looking after it rather than threatening its destruction. I therefore urge you to reject this planning application.

The demolition of Athlone House would cause substantial harm to the character and appearance of the Conservation Area and Hampstead Heath.

Athlone House is a building of architectural importance, rich in architectural detail and is part of the architectural heritage of the area. It is still capable of being restored so that it can be enjoyed by future generations rather than being demolished for short term gain.

Failure to retain and restore the house is in breach of the original s 106 Agreement and planning permissions granted to erect flats at the site. How can the Council ignore this and sanction the wilful neglect of the building?

I am writing to you to express my very strong objection to the most recent application by developers to be allowed to destroy Athlone House and replace it with what looks like a very enormous monstrosity of an alternative.

For a start it is surely a disgrace that the developers of the flats already built have not been forced to carry out their original obligation of restoring Athlone House, and seem to be getting away with flats that are totally out of keeping with the older main building.

I have, in fact, a very personal reason for wanting Athlone House to be preserved.

As a school girl in the 1930s, my best friend was the niece of the owners of Athlone House at that time. As very earnest and committed tennis players (and members of our School Tennis Team) Anne and I were allowed to practice tennis playing on the tennis court down on the court below the house - regularly at weekends and sometimes also on Wednesdays. Afterwards, on Sundays we would be invited to 'take tea' with the family in the drawing room.

Consequently I became very aware of the size, the atmosphere and uniqueness of this extraordinary 'house', which seemed more like one of the fairy-tale castles of central Europe often depicted in fairy-tale books. Many years later, in the 1970s after my husband died, I came to live in Highgate in Millfield Lane, and would recall those years and my friend whenever I saw the house when walking on the Heath.

As I say, it is such a unique house - (it should be in capital letters, HOUSE) We should be proud to have it as part of north London's heritage and not let it just be discarded. Also it played a vital part in London's defence during the WW2 - which should never be forgotten either.

Yours sincerely Barbara Abraham NW3 I am writing to oppose planning application 2013/7242/P, to demolish and replace Athlone House on the borders of Hampstead Heath.

Athlone House is an interesting and historic piece of architecture, which ought to be preserved. The house is now nearly 150 years old and is a fine example of Victorian architecture: I know the house well as I regularly visited it when it was a hospital to play music to the residents and I know therefore that it has retained its original features inside, as well as outside. We have surely long since got past the attitude that Victorian architecture is not worth preserving (which would for example have seen St Pancras demolished), and if so fine an example as Athlone House can be demolished, then no Victorian building in the area can be considered worth preserving. If it were refurbished as originally required by the Council, it would make a wonderful home or public building.

I understand that the developers wish to replace Athlone House with a much bigger building – one which is 60% larger than the existing house. Such a building would dominate the view from the Heath at the much used entrance to this near the Kenwood stables. As a frequent walker on the Heath I love the view across to Highgate village of fields and woods with just Athlone House, one other more distant house and a church spire visible but blending into their natural surroundings. The proposed modern, much larger building, will stand out, unlike Athlone House. I understand too that its size would also contravene the rules that relate to the replacement of houses in the Heath area as it is Metropolitan Open Land.

Finally, planning permission was only given to build new houses in the grounds of Athlone House on condition that the original house itself was kept and restored. It is vital that the Council should enforce the original requirement to preserve and refurbish Athlone House – if it does not in such a high profile case, developers will know that they can ignore any such requirements in future.

In conclusion, the Council must uphold its original decision that Athlone House should be preserved and refurbished and not allow private gain to override the preservation of a part of our heritage and a part, moreover, which will affect the thousands of people who visit Hampstead Heath, and for whom it is a major contributor to their quality of life.





As long-term local residents, we object strongly to the proposed demolition of Athlone House and its replacement by a much larger and more obtrusive building, on the following grounds:

1 - There is no good case for the demolition of the existing building

1.1 The building is a historic landmark which sits well over the north east of Hampstead Heath

1.2 The building is of some significant architectural interest and the Conservation Area would not be enhanced by its removal

1.3 The building stands on Metropolitan Open Land on which such development, notably replacement by a significantly larger building, is precluded by Policy

1.4 The building, despite some neglect, it in sound condition structurally and is capable of refurbishment and bringing into use for either private or public purposes

1.5 The building is subject to a Section 106 Agreement, made in 2005 and amended in 2006 and 2008, which provides for its preservation and refurbishment: this agreement is binding on the current owners.

2 - The proposed replacement building is inappropriate for the site

2.1 It is excessive in scale, being close to double the existing building, clearly inappropriate for Metropolitan Open Land

2.2 It would be much more visible and obtrusive from several key viewpoints on Hampstead Heath, notably from the important viewpoint east of Kenwood House

2.3 The pretentious neo-classical style and light coloured finish proposed would be totally out of keeping with the position

2.4 Following the tasteful restoration of Kenwood House, it would be disgraceful to permit its closest neighbour to be vandalised in this manner.

Camden correctly turned down the previous application to develop this site, and were supported in this by the Planning Inspector; since then the plans have been changed in some minor ways but all the arguments against the previous proposal still apply to this one.

We therefore urge Camden to refuse this destructive application.

- The Developer freely entered into the S106 agreement, to restore the house and 2 cottages in return for receiving planning approval to erect about 24 large apartments, on which he has made a substantial profit
- Nothing has changed since this agreement was made, and it is ESSENTIAL that Camden Council now enforces its conditions to restore Atlone House, Caen Cottages, and the Gatehouse

To Whom It May Concern

As both a local resident and as a practising architect with considerable experience in conservation of historic buildings, I am writing to urge Camden Council to reject any applications to demolish Athlone House in Highgate. Furthermore, I believe the original agreement to restore this significant local building should be enforced.

The grounds for my objection are as follows:

1. The construction of flats previously permitted in 2005 was on the express condition that the historic house be conserved, even if it was to be subsequently sold on .

2. Restoration and reinstatement is viable. It is my understanding that the cost of such would be a fraction of the cost of the proposed newbuild.

3. The newbuild proposals allow for a much larger residential footprint, and this is not allowed so near to Hampstead Heath (Metropolitan Open Land rules)

4. It is the wrong style, with inappropriate colours and details. Its also far too big and should not try to compete with an authentic neoclassical historic building such as Kenwood House, recently overhauled. What is proposed is in any case out of keeping with the predominantly Georgian/Victorian/Edwardian character of its immediate surroundings. Notwithstanding the previous comment, it is my view (in line with the principles of The Society For The Protection of Ancient Buildings) that, were any new building to be allowed on the site, it should preferably be a high quality design of its own time, instead of faking history.

5. The destruction of historic fabric is inherently unsustainable in terms of the embodied carbon value of its materials, and therefore in principle, contradicts any assertions regarding potential CO2 asvings to be achieved with a major and highly specified 'top-end' newbuild, even if it could be shown to be theoretically energy efficient, BREEAM -compliant etc. Anyone familiar with how construction actually works, knows exactly how these matters can be finessed in planning, in full awareness that any such environmental conditions cannot adequately be enforced during the actual build due to the shortage of suitably qualified specialist planning officers.

I oppose this wanton destruction and the tasteless ostentation of the developer-Palladian that is proposed as its replacement.
