I received a copy of the Planning Application for the Rear dormer extension with Juliette balcony at 32 Sherriff Road on the 22nd August. Having spoken with Patrick Flannery, the owner of 30B Sherriff Road (who lives above me) we had a look at the proposed extension. As can be seen from the attached photo the work is almost complete, including TV aerial. Little point in sending a Planning Application Consultation notice! Dear Sir or Madam

I would be grateful if you would check your records regarding the above property. I own Flat 30 A Sherriff Road and scaffolding has been erected both at the front and back of 32 Sherriff Road. The upper flat has been acquired for investment purposes and is being gutted.

The scaffolding has no safety nets and the balconies at the back of 30A and B look like Brighton beach with debris from the building works. My plants have also been destroyed. More concerning is that the waste pipe erected up the back of the building is not secured at the top other than by tying it to the scaffolding. Prior to the scaffolding it rocked in the wind. The builders have also created a window overlooking the roof terrace of 30B so that they have lost their privacy. Is this allowed without prior consultation or planning permission? The other residents of 32 Sherriff Road were also not informed of any

building works which caused a great deal of distress to the young mother and baby living in the garden flat due to noise and debris falling in the garden.

Would you please advise me as to whether builders are allowed to work on Saturday?

I would be grateful if you would investigate this planning application and let me know whether this window is legal. I may be contacted on [REDACTED] if you have any further queries.
