 Site description: The subject site relates to a gran period building, which has been divided into flats. The building is finished in red facing brick and roof slates to the roof and turret roof. The building, 7 Lyndhurst Gardens, is identified as making a positive contribution to the Fitzjohns/Netherhall Conservation Area.
 The roof light would be Conservation style, flush with the roof slates and will be finished in lead/aluminium. The window is made of 3mm mild steel.
