Ash (Fraxinus excelsior) Buddlia (G3)      Rear garden left hand boundary Fell as close to current ground level as possible and leave stump in ground. (no grinding required)

Bay (Laurus nobilis) (T4)      Rear garden left hand boundary.Cut back by approximately 2m.
