This semi detached Victorian house has been split into flats. The main part of the house bordering the street comprises 3 floors including the ground floor. This occupies almost the entire area bordering the street, except for the alleyway, which borders the adjacent house. The second part of the house extends back into the garden, and does not occupy the same width as the main part of the house. It occupies only 2 floors of this rear portion of the house, of which 25a comprises the ground floor. 25a also solely occupies the ground floor of the main part of the house.

The new width would be acceptable, the length of the proposed extension to be reduced to the old kitchen wall, the roof to be made a dual pitch roof of similar material to the existing main building roof. This was shown on the application, but after a conversation with Mr O. Nelson, Camden planning officer on site, we are resubmitting the application with an increased length, as otherwise it would not be viable.. Though marginally different, an extension as has been permitted on the successful recent adjacent planning application at no.21A is proposed.
