I attach a copy of an email I sent one of Almacantar's advisers following their display exhibition earlier this year. As you will see, I had asked them to inform me when the application was submitted, but they appear to have failed to do so. I recently became aware that the application had been lodged.

I understand that the Council is accepting submissions out of time.

Please consider the comments in the forwarded email as submissions in relation to the application.

I am sure the Council is aware of the very significant transfer of value which any grant of planning will entail.

I understand the Council has requested the developer to consider allowing a viewing platform at the top of the building, but that has been rejected. In view of what has been shown to be achievable at the Shard, this rejection needs to be tested.

My comments below about the proposed segregated social housing speak for themselves. A recent picture of this tip of the site showed quite how intrusive (as well as ugly) the proposal is. It bears no relation to the surroundings (including Centre Point itself).

I understand that there are questions about the adequacy of the specifications in relation to the affordable housing.

More generally, I doubt whether adequate consideration has been given to pedestrian safety.

Please advise when the hearing on the application is to take place.

I welcome the new consultation about this project.

I set out below a few thoughts:

- I am not sure about the exact timing and how it would interrelate with Crossrail/ Tottenham Court Road station upgrade and also with the proposed Denmark Street redevelopment. There could be an awful lot of construction work (and the associated traffic) going on at the same time.
- I am concerned generally that there may not be enough pedestrian space in the area, with the
 anticipated numbers exiting from the Crossrail and Tottenham Court Road stations. This may be
 exacerbated if Consolidated go ahead with their "21st century Times square" proposals. I note that
 sorting out the space at ground floor level is being deferred. This seems just to be avoiding the issue.
- On the other hand, it seems simplistic to displace bus routes and stands into already busy side streets.
- The arguments offered against a viewing platform seem very weak, although I recognise that having a viewing platform could jeopardise the entire project.
- My main concern relates to the affordable housing. Quite apart from the "policy" issue of moving social housing into a ghetto at the tip of the site, the model of the proposed tower structure is extraordinarily ugly, devoid of architectural merit and lacking in any stylistic connection with the existing buildings among which it is proposed to insert this structure. At one point, I thought it was just a place holder. The fact that the developers can put it forward makes one wonder how seriously concerned they are about the architectural environment. Quite apart from the impact on Centre Point itself, the proposed structure would disfigure the views around 5t Giles Church. Pedestrian access to the building could also be very dangerous. I should add that the posters appeared to convey the misleading impression that the social housing would be no more intrusive than the very low level existing pub.


