Thanks for your e-mail. We must have got the uploading wrong onto the website – my apologies. I also apologise for the slow reply, but I was on leave.

I have attached the letter that we sent in May 2014 with the original query about this planning approval. Was this the letter that you meant? The non-material amendment forms sent last month are also attached. We had a problem with the upload sizes permitted, so some of the original drawings included in the first letter for comparison were omitted, and this may have caused your query.
