1 Sycamore	(Acer pseudoplatanus)	Large,mature tree. This tree has had some lateral reduction work done to clear property. Suggested works are: to reduce back to previous points of reduction, lateral spread (previously reduced), crown thin remainder by 10-15%, remove deadwood.

2 Cherry x 2	(Prunus spp)	These two trees have been reduced in the past. To maintain this suggested works are: to reduce back to previous points of reduction, remove deadwood each.

3 Black Poplar	(Populus nigra)	Extra large, mature tree. This tree has been pollarded in the past. As with most black poplars, there is extensive amounts of re-growth on the main stem which overhangs into Oak hill Park Mews. The whole tree will need to be re-pollarded in 12 months time. Suggested works are: to remove all overhanging truck growth to crown break.

4 Lawsons Cypress	(Chamaecyparis lawsoniana)	This tree has outgrown its location, it is starting to damage the boundary wall and block light. Suggested works are: to fell to ground level by sectional takedown.


