Replacement of 3 x timber framed windows above the sliding patio door with windows to match existing, replacement of existing 3 x aluminum sliding doors with double doors at the rear elevation and the replacement of existing 3 x windows to the side elevation with new timber framed windows.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 and DP25 of the London Borough of Camden Local Development Framework Development Policies.

The development hereby permitted shall be carried out in accordance with the following approved plans 5913/01, 5913/02, 5913/03, 5913/04, 5913/05.

For the avoidance of doubt and in the interest of proper planning.
