We would like to change the frame of the 1st and 2nd floor windows as an aesthetic preference, it will also allow more light into the property. We would like to enlarge the ground floor window at the front of the property so that it allows more light into the playroom. We would like to change the rear ground floor glazed doors to three glazed panels with one central sliding door and two fixed panels on either side, to improve the use of these doors by the inhabitants. We would like to remove the Juliet balcony to the first floor level as it serves no purpose as there is no access to the outside at this level. Removal of the small high level window to the front elevation as it an aesthetic decision to improve the appearance of both the front elevation and the internal elevations.

The proposed variations are as follows:  
- Amendment to the frame of the 1st and 2nd floor windows on front and rear elevations, from 3 panels to 2 panels  
- Enlargement of ground floor window on front elevation  
- Amendment to ground floor glazed doors on rear elevation from 1 sliding door and 1 fixed panel to 1 central sliding door with 2 fixed panes on either side.  
- Removal of the Juliet balcony at first floor level.  
- Removal of the small high level window on the front elevation.
