The small spaces for trees and gardens at the end of each terrace is an integral part of Powell and Moya's design and contributes very positively to Lamble Street's and Grafton Road's character. Losing those spaces would impoverish our local streets and places.</p> <p>I recognise that Camden needs all the new housing it can find but I am asking the planning committee to re-consider the importance of these three sites in relation to loss of neighbourhood amenity and the relation of new construction to historically important modern architecture.</p> <p>Hayhurst and Co are outstanding architects and I am a little surprised to see their proposal. If houses must fill the three garden spaces, please ask them to consider more modest building that has some relation to the character, scale and height of Powell and Moya architecture.</p> <p>The houses shown in a rather crude drawing are not an architecture I would like to have in my daily surroundings. The design of the houses is not, in my view, of a high enough quality to justify planning permission.</p> <p>I must confess that I am usually on the other side of this argument, but for Grafton Road I think Camden has misjudged the impact of these small projects on an important local environment.</p>
