The above trees are blocking light and shading flower beds and the lawn. The neighbour's Sycamore trees (T1 &T2) are too close to no.10 and shading the patio area. The neighbour's lime trees are interfering with flower beds and T6 and T5 are becoming dense and shaded. The neighbour is happy for the trees to cut back.
