We advise: Fell the tree as close as possible to ground level and grind out the stump.

T2 - Small Sycamore tree - There is decay present at old pollard points and also a cavity in the tree trunk at about 3m.

We advise: Fell as close as possible to ground level and grind out stump.

Supply and plant two trees - One flowering Cherry Tree and one Dawson tree - Client to confirm size and species of trees.
