A small glass conservatory was erected at the rear of Flat B, 37 Patshull Road, at some point between 1977 and when it changed hands in 1985. It was erected without Planning Permission.

We bought the flat for my mother to live in, in 2001. Solicitor's letter dated 11 June confirms.

A letter signed by neighbours at 39 Patshull Road confirms that it was there when they bought their house in April 1996.

It now needs repair or rebuilding, and we would like to know that no enforcement action would be taken to remove it.
