Hawthorn (12) - fell because of tree misshapen as a result of being planted in the shade of the surrounding lime trees. Growth suppressed by dominant trees.

Magnolia (13) - fell because of proximity to structure casting dense shade in adjacent room and to increase the accessibility of the garden to its users.

Elder (14) fell because of proximity to structure and that the tree is partially deceased and is subject to damage from the structure.

A landscape designer has been appointed and is currently developing a scheme for the garden that completely sympathises with the removal of these trees by allowing for the planting of three mature trees to replace the trees identified for removal. These trees would be positioned around the perimeter of the garden between existing trees using one variety of species in order to create unity. Attributes for the new trees would include several seasons of interest, a dense canopy for screening and an appeal to wildlife. An example would be an improved variety of hawthorn *Crataegus x Prunifolia Splendens*.
