The proposal requires demolition of an existing rear extension. This consists of an earlier single storey brick, pitched roof extension constructed later than the original house. The date is unknown but is estimated to be during the 1960s. A glazed conservatory dating from 2004 will also be demolished.

The previous extensions are poorly connected to the original house, and will be replaced with a new living space linking house and garden.
