Reduce regrowth back to previous points by approximately 2-3 metres to manage column.

Prune Cherry (ID 2) located at the rear garden of neighbours property according to the following specifications:

Reduce overhanging branches by approximately 1-2 metres to provide clearance to 20a garden.
