### **Assessment**

#### Proposal

Planning permission is sought to replace three timber sash windows and one front casement window in the rear elevation of the property. The new windows will be timber framed and double glazed; the existing windows are timber framed, single glazed. The proposed windows will match the existing in terms of size, opening style and number of windows panes.
