Erection of single-storey infill extension at rear ground floor level, including replacement of flank wall on west side of 2-storey closet wing with Chestnut timber clad finish, plus new bay-window to single family dwellinghouse.

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 All new external work shall be carried out in materials that resemble, as closely as



possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 and DP25 of the London Borough of Camden Local Development Framework Development Policies.

3 The development hereby permitted shall be carried out in accordance with the following approved plans [Location plan; 109 S 00; 109 S 01; 109 S 10; 109 S 11; 109 S 20; 109 S 21; 109 S 22; 109 P 00; 109 P 01; 109 P 10; 109 P 11; 109 P 20; 109 P 21; 109 P 22; Design & Access Statement, July & October 2014.]

Reason: For the avoidance of doubt and in the interest of proper planning.

- 1 Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts which cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings.
