The Black Poplar located in the in the back garden of 203 Goldhurst Terrace 5.9 metres from the foundation of 130 Belsize Road and 132 Belsize Road. Jamie Ryan, Treescapes 07812212145 Treescapesn6@hotmail.com, recommended reducing back inside by 2 to 3 meters from the previous reduction points at its height. The attached drawing displays a red line that indicates, approximately, pollarding 2 to 3 meters at its high beyond the previous reduction points. All points lower than this will be pruned back to their previous points. In this manner, we would gently reduce the volume of the crown and retain its amenity value.
