5	Himalayan Birch	Betula utilis	Rear left	Triple stem. Judiciously reduce height and lateral spread by 1-2m and balance crown.	
6	x2	Evergreen Magnolia	Magnolia grandiflora	Rear centre left	Reduce and reshape by 0.5m approx and round off
7	Snakebark Maple	Acer capillipes	Rear left	Reduce and reshape all round 25-30% to contain spread and improve light and space. Remove 2 low side branches growing towards Holly. Clean out crown and remove deadwood.	
8	x2	Holly	Ilex aquifolium	Rear centre left	Trim up all round to contain spread and clean out crown, lift and remove deadwood
9	Aspen	Populus tremula	Rear left corner	Very large mature tree: To contain spread and improve light all round: Reduce crown all round by 1-2m to previous reduction points, retain crown continuity. Thin and clean out crown, remove deadwood, weak and suppressed branches and suckers.	
10	x3	Sycamore	Acer pseudoplatanus	Rear boundary	Large mature tall trees to contain spread and improve light and space all round and lessen oppressive feel: Reduce crown all round 25-30% to previous reduction points, retain crown continuity. Thin and clean out crown, remove deadwood, weak and suppressed branches and suckers
