- T4 = Hawthorne - We advise: Lift crown by removing the lowest limb.
- T5 = Conifer - We advise: Lift crown to clear Plum tree.

#### REAR GARDEN

- T6 = Bay tree - We advise: Reduce crown by 30% and lift.
- G2 = Mixed vegetation - We advise: Cut back from property to allow clearance.
- G3 = Shrub - We advise: Prune to shape and tidy up.
- G4 = Mixed vegetation - We advise: Cut back from neighbouring property to allow clearance.
- G5 = Mixed vegetation - We advise: Cut back to allow at least 1 metre clearance.
