Rear Garden

Silver Birch: Approximately 13M. Condition fair/good. This fine tree is a key feature within the garden. It would be prudent not to let the tree exceed its current size and dimensions as the available growth space within the garden is limited. A balanced and measured approach to the on going management of this tree would be advisable in order to ensure the tree's health is maintained and that neither crown die back or undue reactionary re-growth is induced by pruning works. Judiciously reduce crown by up to 20% by means of selecting overlong extraneous branches and pruning back into main crown structure. To include reduction of branches overhanging the garden by 15-20%. Remove dead wood and broken branches throughout crown. This action will increase light levels to the garden, reduce potential hazards and help curtail tree's sphere of influence in relation to walls and buildings whilst preserving natural characteristics and aesthetic value.

Malus: Crab apple cultivar. This smaller specimen, although somewhat suppressed, has merit for its character and screening properties. It also adds balance to the garden. Remove dead wood and broken branches. Thin crown density by approximately 15-20% and remove epicormic growth.
